2. DO NOT write within the borders of the certificate itself.
3. Name of buyer, membership number and address must be accurate to insure proper delivery of registration papers.
4. Seller's name and membership number should agree with membership application on file with AAKA and also with "Recorded Owner" as shown on the face of the Certificate of Registration.
5. This transfer is not valid unless signed by the recorded owner or an authorized representative recorded with AAKA.
6. The transfer fee is the obligation of the seller, unless otherwise agreed upon, but fee rates will be based on the membership status of the seller.
7. If an animal is multiple owned, please indicate the percentage of interest being sold next to the buyer's name.
8. All cattle, including calves-at-side, must be registered prior to transfer, regardless of age. If the calf-at-side is younger than 250 days of age and sells at side of dam, one transfer fee will be charged. If the pair is split and the cattle go to two separate buyers, two transfer fees will be charged.
